<p><b>Third Party Supplier Information</b></p> <p><b>By entering into this contract, you are agreeing to purchase your electric supply from this supplier.</b></p>	<p><b>State of New Jersey License Number: ESL-0081</b>  <b>IDT Energy, Inc., 520 Broad Street, Newark, NJ 07102</b>  <b>877-887-6866, contactus@idtenergy.com www.IDTEnergy.com</b></p> <p>You have chosen IDT Energy as your third party supplier (TPS). IDT Energy is not affiliated with your electric distribution company (EDC). IDT Energy is responsible for your electricity supply. The charges for the electricity supplied by IDT Energy will appear on the bills rendered to you by your EDC, separate and apart from your EDC's charges for delivering the electricity.</p>
<p><b>Price Structure</b></p>	<p>For the first 12 monthly billing cycles the rate will be fixed. After that, the rate may vary based on numerous factors, including the ones detailed in the Terms &amp; Conditions. There is no cap on the variable rate.</p>
<p><b>Generation/ Supply Price</b></p>	<p>The fixed rate for the first 12 monthly billing cycles will be «RATE» cents/kwh.</p>
<p><b>Statement Regarding Savings</b></p>	<p>The rate may be higher or lower than the EDC's rate in any month. There is no guaranty of savings.</p>
<p><b>Amount of time required to change from TPS back to default service or to another TPS</b></p>	<p>If you cancel your IDT Energy service to return to your EDC or to switch to another TPS, the change will take effect on the next available billing cycle date in accordance with your EDC's rules. It may take one or two billing cycles from the submission of the cancellation request.</p>
<p><b>Incentives</b></p>	<p><b>Rebate Program:</b> the Customer must remain in the program for the entire agreed upon term in order to qualify for the rebate. If a Customer cancels at any time prior to the agreed upon term, the Customer shall forfeit all rights and claims to any and all rebate offers. <b>Introductory Price:</b> will be in effect for the introductory price term, at which point the account shall update to the IDT Variable Price and continue on a month to month basis.</p>
<p><b>Right to Cancel/Rescind</b></p>	<p>If you are a residential customer you may rescind your selection of IDT Energy by contacting your EDC (or by calling IDT Energy at 1-877-887-6866) within seven days of the date of the EDC's confirmation notice.</p>
<p><b>Contract Start Date</b></p>	<p>You will begin receiving electricity supply service from IDT Energy as of the next available billing cycle date as determined by your EDC.</p>
<p><b>Contract Term/Length</b></p>	<p>The fixed rate segment of this Agreement is twelve (12) monthly billing cycles and this will be followed by the variable rate segment which will continue until either you or IDT Energy provides 30 days' notice of termination to the other.</p>
<p><b>Cancellation/Termination Fees</b></p>	<p>If you terminate this Agreement during the fixed rate segment, or if IDT Energy terminates this Agreement during the fixed rate segment due to your breach, you will pay a termination fee, as liquidated damages and not as a penalty, for each terminated account, equal to: \$10.00 for each month, or portion thereof, remaining in the fixed rate segment multiplied by the RCE Value (as defined in the Terms &amp; Conditions) of the account.</p>
<p><b>Renewal Terms</b></p>	<p>This Agreement will continue until either party terminates it.</p>
<p><b>Distribution Company Information</b></p>	<p>The EDC will continue to deliver the electricity to you and you will continue to make payments to the EDC for this service. In the event of any emergencies or outages you should call the EDC.</p>

**IDT Energy, Inc. (“IDT Energy”) Fixed Rate (SmartBudget) Terms and Conditions - V.01132017 - ETF**  
**State of New Jersey Electric License Number: ESL-0081**

**1) SCOPE.** This is an agreement (“Agreement”) between you (also referred to as “Customer”) and IDT Energy, an independent third-party electricity supplier, under which you authorize enrollment of your electric account(s) with IDT Energy for electricity supply. These terms and conditions apply to the purchase by you and sale by IDT Energy, of electric generation supply service as specified herein.

**2) AGENCY.** Customer designates IDT Energy as its agent for receiving customer billing information from the local electric distribution company (“EDC”), and for procuring and scheduling the transmission and ancillary services necessary to deliver the electricity purchased by you to your EDC’s system.

**3) PRICE. A fixed rate is a rate that remains the same for a specified period of time. A variable rate is a rate that changes from time-to-time based on various factors, including weather fluctuations.** This Agreement has a fixed rate segment and a variable rate segment. For the first twelve (12) monthly billing cycles of your electricity supply pursuant to this Agreement, the rate for the electricity supplied will be fixed at \_\_\_\_\_ per kWh. After that, the rate for the electricity supplied will vary based on a number of factors including, but not limited to, current conditions on the PJM wholesale electricity market, the actual and estimated cost of obtaining electricity from all sources, capacity costs, settlement costs, costs of ancillary services, hedging costs, balancing costs, line loss costs, costs to comply with any applicable Renewable Portfolio Standards, IDT Energy’s expenses and margins, and all applicable taxes, fees, or assessments. IDT Energy’s rate, whether fixed or variable, may be higher than your EDC’s rate at any particular time; there is no guarantee of savings. For each monthly billing cycle, the price for the electricity supplied pursuant to this Agreement will be calculated by multiplying: (i) the fixed or variable rate for electricity, by (ii) the amount of electricity consumed as measured by your EDC’s estimated or actual meter reads.

**Rebate Programs:** From time-to-time IDT Energy may offer a Rebate Program. If Customer participates in IDT Energy’s Rebate Program, Customer must remain an active IDT Energy customer in order to qualify for the rebate(s). If Customer cancels at any time prior to the issuance of the rebate(s), Customer shall forfeit all rights and claims to such rebate(s). All rebate amounts advertised and presented to customers are estimates based upon prior electricity usage. Actual rebate amounts will be based on Customer’s actual usage, which may vary from any estimate provided. IDT Energy will send any rebate or promotion payment to the customer address given to IDT Energy at the time of enrollment. It is the responsibility of Customer to notify IDT Energy of any changes to Customer’s address either by writing to IDT Energy at 520 Broad Street, Newark NJ 07102 or by calling IDT Energy’s Customer Service Dept. at 1-877-887-6866. IDT Energy will send all rebates and promotional payments via the US Postal Service and is not responsible for invalid addresses or undelivered items.

**Renewable/Green Energy Option:** Renewable/Green energy refers to energy that is generated from renewable sources, such as solar, wind, water or biomass. If a customer chooses the Renewable/Green Energy Option, IDT Energy will ensure that 100% of the customer’s electricity usage is matched with renewable energy certificates or renewable energy attributes. IDT Energy shall have up to 24 months from the end of each calendar year to address any deficiency that may have arisen in the renewable content of electricity sold under this Agreement during such calendar year.

**4) BILLING and PAYMENT.** You will normally receive one bill each month issued by your EDC, or by IDT Energy. Unless otherwise provided herein, payment terms are governed by the terms of your EDC’s tariff if your EDC issues the bill. If IDT Energy issues the bill, payment of the full amount billed is due 25 days after the date the bill is mailed. Late payments or partial payment balances will be subject to collection fees and/or reasonable attorney’s fees and court cost, as allowed by law. All accounts which are overdue may be referred to a collection agency consistent with New Jersey law. Your bill will be based on scheduled meter readings and/or estimates provided by your EDC. The parties agree to accept, for purpose of accounting for the electricity delivered under this Agreement, the quantity, quality, and measurement determined by your EDC. A twenty-dollar (\$20) fee will be charged for all returned checks.

**5) TITLE and TAXES.** Under this Agreement, title to the electricity shall pass from IDT Energy to you prior to delivery to your EDC. IDT Energy’s rate includes applicable sales taxes.

**6) TERM; TERMINATION; TERMINATION FEES.** You will receive a confirmation notice from your EDC to confirm your choice of IDT Energy as your supplier. A residential customer will have seven (7) calendar days from the date of the notice to contact the EDC (or call IDT Energy at 1-877-887-6866) and rescind the selection of IDT

Energy. This Agreement will not become effective until the seven-day confirmation period has expired. The fixed rate segment of this Agreement is twelve (12) monthly billing cycles and this will be followed by the variable rate segment which will continue until either IDT Energy or Customer provides 30 days' notice of termination to the other. Residential customers may terminate this Agreement upon 48 hours' written notice as a result of relocation, a disability that renders the customer unable to pay for IDT Energy's services, and/or the death of the customer. If there is a material adverse change in the business or financial condition of Customer (as determined by IDT Energy at its discretion) or if Customer fails to meet its obligations under this Agreement or pay or post any required security deposit, then, in addition to any other remedies that it may have, IDT Energy may terminate this Agreement upon 30 days' written notice to Customer. There is no charge for starting or stopping electric generation service, however, if Customer terminates this Agreement during the fixed rate segment thereof, or if IDT Energy terminates this Agreement during the fixed rate segment thereof due to Customer's breach, Customer shall pay IDT Energy, in addition to any other applicable charges, a termination fee for each terminated account equal to: \$10.00 for each month, or portion thereof, remaining in the fixed rate segment of this Agreement multiplied by the RCE Value (as hereinafter defined) of the account. [The relative size of energy accounts is measured in Residential Customer Equivalents (RCEs). For electricity, one RCE represents annual consumption of 10,000 kWh. Using an RCE as the basic unit of measurement, IDT Energy assigns an "RCE Value" to each customer account based on the usage history for the account and other relevant factors.] The parties acknowledge and agree that the actual damages that IDT Energy will suffer as a result of Customer's early termination or breach are difficult to assess, the termination fee described herein is a reasonable estimate of such damages, and such termination fee constitutes liquidated damages rather than a penalty. Please note that it may take several billing cycles for your EDC to process the cancellation of service.

**7) ASSIGNMENT.** IDT Energy may assign or transfer its rights or obligations under this Agreement after first informing you in writing of such transfer or assignment. You may not assign or transfer your rights or obligations under this Agreement.

**8) CHOICE OF LAW.** This Agreement shall be construed in accordance with, and be governed by, the laws of the State of New Jersey with regard to the conflicts of law provisions thereof.

**9) NO WARRANTIES.** THERE ARE NO WARRANTIES OR REPRESENTATIONS OTHER THAN THOSE EXPRESSLY SET FORTH HEREIN, AND NO OTHERS SHALL BE HONORED. Should any part of the Agreement be declared invalid for any reason, such decision shall not in any manner affect the validity of the remaining portions of this Agreement, which shall remain in full force and effect as if the part determined to be invalid has not been contained herein at the time of the execution of this Agreement. If at some future date there is a change in a law, rule, or regulation, whereby IDT Energy is prevented, prohibited or frustrated from carrying out the terms of this Agreement, then at the sole discretion of IDT Energy, this Agreement may be cancelled. If at some future date, there is a change in a federal or state approved tariff affecting IDT Energy's cost to purchase electricity required to provide your service, then, at the sole discretion of IDT Energy, this Agreement may be modified to reflect those costs, in which case IDT Energy will provide you with a written notice of such modification.

**10) FORCE MAJEURE.** Except as otherwise set forth herein, force majeure is the only excuse for non-performance and all other excuses (at law or in equity) are waived. Except from payment obligations, a force majeure event will, upon notice, excuse both parties' performance during the event. "Force Majeure" means those events not reasonably anticipated on the effective date hereof and outside the control of the claiming party and include force majeure events associated with your EDC or the commodity supplier or other entity used to deliver electricity to Customer's residence.

**11) LIMITATION OF LIABILITY.** In no event shall IDT Energy or Customer be liable to the other or to any third party for any indirect, incidental, consequential, punitive, reliance or special damages, including without limitation, damages for lost profits, advantage, savings or revenues of any kind or increased cost of operations, whether or not IDT Energy or Customer has been advised of the possibility of such damages. Customer acknowledges that IDT is not responsible for the delivery of electricity to Customer and as such is not responsible for any damages caused by any service outage, defect or failure. IDT Energy's liability for claims arising in connection with its service under this Agreement, shall be limited to proven direct damages incurred by Customer, if any.

**12) INDEMNIFICATION.** Customer is responsible for the indemnification of IDT Energy against any and all liabilities resulting from Customer's failure to fully comply with this Agreement, except liability resulting from the negligence of IDT Energy.

**13) ENTIRE AGREEMENT.** This Agreement, including the Contract Summary, constitutes the entire agreement between you and IDT Energy. You acknowledge that you are not relying on any advice, statements, recommendations or representations of IDT Energy or its sales personnel other than those made in this Agreement, and that you have made your own decision to enter into this Agreement. Customer has caused this Agreement to be executed pursuant to the methods authorized by BPU regulations at N.J.A.C 14:4-2.3.

**14) DISPUTE RESOLUTION, MANDATORY ARBITRATION** You agree to contact IDT Energy in writing and attempt to resolve all billing disputes or service problems directly in good-faith. All disputes regarding transmission, distribution, power outages, and bills from your EDC should be directed to your EDC. Any claim for damages arising out of, or related to, the provision of IDT Energy's services under this Agreement that is not resolved directly between the parties, shall be resolved by arbitration before the American Arbitration Association ("AAA") conducted under the AAA Commercial Rules and, if Customer is a residential customer, the Consumer-Related Disputes Supplementary Procedures.

BY ENTERING INTO THIS AGREEMENT, YOU ARE GIVING UP YOUR RIGHTS TO SEEK MONETARY DAMAGES IN COURT, AND THE RIGHT TO A JURY TRIAL. THE ABILITY TO CONDUCT DISCOVERY IN ARBITRATION IS LIMITED AND THE ARBITRATOR'S DECISION IS SUBJECT TO VERY LIMITED REVIEW BY COURTS. ARBITRATORS CAN AWARD THE SAME DAMAGES AND RELIEF THAT A COURT CAN AWARD. THE AAA SHALL HAVE THE POWER TO RULE ON ANY CHALLENGE TO ITS OWN JURISDICTION OR TO THE VALIDITY OR ENFORCEABILITY OF ANY PORTION OF THIS ARBITRATION PROVISION.

**15) PROTECTION OF CUSTOMER RIGHTS.** IDT Energy hereby provides notice that its services are governed by the terms of this Agreement, the rules and regulations issued by your EDC, and the Board of Public Utilities (BPU). The BPU Bureau of Consumer Relations can be contacted at 1-800-624-0241. Your EDC's transmission and distribution functions will continue to be regulated by the BPU. Electric service may be disconnected only by your EDC and only in compliance rules set by the BPU.

**16) CONTACT INFORMATION.** Any questions regarding these terms and conditions or your service with IDT Energy should be directed to us in writing at IDT Energy, Inc., 520 Broad Street, Newark, New Jersey, 07102. IDT Energy may also be contacted at 1-877-887-6866. Your EDC will continue to deliver the electricity to you, you still make payment to your EDC for this service and you will still call your EDC in the case of an energy related emergency such as a power outage.
